#### **Description:**

Mainly 2-storey semi-detached property of brick construction beneath a pitched slate covered roof. The ground floor retail unit is available and extends to 1,150 sq ft (106.8 sq m) approx. The premises provide retail space with full-height glazed frontage to Lytham Road and incorporating rear storage, kitchen and WC.

The first floor flat could be offered in conjunction with the ground floor, if required. Terms for the 2 elements combined on application.
